Minerals & Waste

- The Draft Minerals Plan for SDNP & WSCC has been published and approved by the SDNP Planning Committee. It is now out for public consultation. The good news is that all proposed sites in the Duncton area have been removed from the Plan. Duncton PC will continue to keep a very close watch on the plan.

Village Design Statement

- Councillors have attended two meetings with SDNP to look at the benefits of conducting a Neighbourhood Plan or a Village Design Statement. These meetings were for the villages in the Bury Ward
- Strong recommendation that small villages such as Duncton do not adopt a Neighbourhood Plan especially as there is no mention of any land within the settlement marked for development. Of the villages in the ward only Bury is going forward with a plan, it is a much larger village with land marked out for development.
- The latest meeting has centred around Village Design Statements (Presentation form Chris Patterson to be displayed)
 - The PC is still debating whether it should go down this route. There would be a cost of approx. £3000. It will involve a lot of work by team of volunteers and it would need someone to come forward to lead it. Some neighbouring villages seem to be coming to the decision that the work and cost involved would be a burden and they are unsure of the benefits and value of a VDS. The SDNP Local Plan is still to be published although we have seen the draft. There will be a level of protection in that plan.
