Agenda item no. 1 Apologies

D. Withers has resigned from the Parish Council due to poor health. It was unanimously agreed that she should receive thanks and admiration from all present for the contribution she has made to Duncton Village through her work with the Parish Council.

It was also reported that due to work commitments R. Boult is resigning from the Parish Council. Thanks go to her also for her contribution.

Agenda item no. 2 Declarations of interests:

Agenda item no. 3 Minutes from the Meeting on 8th January 2015

Signed as correct record with amendment at Agenda Item no. 17 – the correct date being 23rd October and the amount raised so far £150.

Agenda item no. 4 Clerk's report on action points from the 8th January 2015 meeting

- a) Barclays Bank account set up everything is now in place to open the account. A discussion took place on the most financially secure way to proceed, to keep two accounts open or to move all to Barclays. It was RESOLVED to move all funds to Barclays and close the Co –Operative Bank account as it was still felt that this bank would be a risk. (ACTION A. Harte)
- b) Property Marking An advert was put in the Parish Magazine to which no one responded therefore no further action will be taken.
- c) Neighbourhood Plan Marie Bracey will meet with Jeremy Aitchison on Monday as he has prior experience and may be able to assist with this.
- d) There are no appropriate properties to put onto the Community Right to Bid Register within Duncton.
- e) The Double white lines on Duncton Straight appear to have improved the situation. There are still works to be done on the straight, potholes, surface dressing and footpath repairs. The VAS is faulty and the wall opposite the Catholic Church is a potential hazard. (ACTION A. Harte to remind highways and ensure all is done)
- f) Village Hall Broadband A. Beadley reported that he had spoken to Nigel and that this was progressing. C. Davies suggested SSE Broadband provider. (ACTION A. Beadsley) With regard to Better Connected Broadband for the village there is slow progress on Cabinet 4. (ACTION) M. Bracey to write to WSCC executive officer to push this on.
- g) A. Harte (ACTION) still to investigate the possibility of holding funds for monies raised by the village for charity.

Agenda item no 5 County Councillor's report

M. Brown was not present and gave his apologies.

Agenda item no 6 District Councillor's report

- a) At the last District Council meeting all taxes were agreed for the coming year.
- b) J. Elliott will be standing for election as District Councillor for the Bury ward again this year. He reported that the number of District Councillors is being reduced which may cause problems in certain areas.

- c) Church Bell- J. Elliot reported that it may be possible to secure funding for the Bell at the Holy Trinity Duncton on the grounds that it is historic or perhaps a warning bell. **ACTION M. Bracey** to pass this information onto Bob Mitchell.

There have been several reports of increased works taking place at Heath End Sand Pit that are creating a considerable noise impact. A communication from Peter Wilsdon was shared with the Council. This proposed an enforcement update meeting take place rather than a liaison group meeting. SDNP are being proactive and M.Bracey will email Peter Wilsdon to reply.

Agenda item no. 10 The Holy Trinity Church Bell

A request from The Holy Trinity Duncton PCC has been received for help funding the repairs to the historic church bell. The repair cost is £7500 and they have raised nearly half the amount required. M. Bracey asked if there were funds in the current year budget that could be reallocated to this cause and was informed that it would be feasible to offer up to £400. It was **RESOLVED** to donate £400 to the Holy Trinity PCC for the Bell. (M. Bracey proposed, P. Darley seconded)

- Repairs to playground It was unanimously RESOLVED to commission Playsafe to do the repairs and replace the tyre swing as quoted. A. Harte and D. Danby to make a decision on the type of seat to use. (ACTION A. HARTE)
- e) Quotes from Sovereign, Playsafe, Hags- SMP and Playdale shown and discussed. It was agreed that the plan and price for equipment was favourable with Playdale although it was thought better to attach playpannels to the railings (ACTION A.Harte to ask for a quote for this)
- f) The Council RESOLVED to investigate grants to cover the cost of £17,000 (ACTION A. Harte)
- g) **ACTION A.Harte** to email Hyde Martlett and the Planning department with the plans of the zip wire to see if this is possible.
